

Your learning journey

The Resource Centre is divided into two key sections. The first focuses on vaccines. The second part explores management and recovery of Covid-19.

Within both sections you will find an array of content, which you can access at any time to suit you during your six-month subscription. Just click on the information that you're interested in and go from there.

The content is made up of podcasts, webinars and articles; and we'll even be running some live Q&A sessions where you can ask the experts those burning questions. And don't forget that this Resource Centre can be used as part of your CPD, so log in regularly to make the most of your six month subscription.

Part one: Vaccinations

When you log into the Resource Centre, a list of different sections will show on the left hand side. To start, we recommend going to the 'Learning about Covid-19 vaccines' section and working your way through it.

In order to meet the minimum training requirements to deliver Covid-19 vaccines, you will need to complete all of the training under the heading 'Administering the vaccine' (circled in the below image), which is found in the 'Learning about Covid-19 vaccines' section. If you will not be administering vaccines, but just want to understand the process further, you will not need to complete the assessments and programme completion form at the end of this section.



When you go into this section you will be able to select from a range of podcasts, toolkits and webinars. These will expand your knowledge on everything from reconstitution technique, storage guidelines to record keeping, PPE and patient aftercare. This is an assessment that is set by Public Health England and must be completed prior to delivery of the COVID-19 vaccine. This assessment is external to Education for Health and you will need to register at that site in order to complete. A pass must be obtained and you can generate a certificate as required.



Patient Group Direction for COVID-19 mRNA vaccine BNTI62b2 (PfIzer/BioNTech) Delivered by NHS UK

Public Health England (PHE) has developed this PGD for authorisation by NHS England and NHS Improvement to facilitate the delivery of the national COVID-19 vaccination programme.



A tool developed by Public Health England that assesses and ensures that anybody administering the vaccine is given the time and opportunity to undertake the comprehensive training they need and that they are supervised and supported in practice as required.



An overview of COVID-19 local vaccination services procedure in community settings.



Public Health England (PHE) has developed this PCD for authorisation by NHS England and NHS Improvement to facilitate the delivery of the national COVID-19 vaccination programme. Let's look at these in more detail:

1) Pre-recorded lectures



Your first step is to work through the pre-recorded lectures. These components currently cover details around the Pfizer-BioNTech COVID-19 and Oxford - AstraZeneca Vaccines (information about other vaccines will be added as and when they become available in the UK). These lectures will provide you details around:

- Vaccine specifics for example, how it is made, how it works, what it contains
- Who the vaccine should be given to
- Contraindications and precautions
- Legal issues including obtaining consent and legal framework to supply/administer the vaccine (PGD/PSD/protocol/patient specific prescription)
- How the vaccine should be stored
- Record keeping
- How to prepare the vaccine
- How and at which anatomical site to administer the vaccine
- How to recognise and respond to side effects following immunisation
- How to dispose of vaccine equipment
- What to expect after vaccination and other information to give those who have been vaccinated
- Where to record that the COVID-19 vaccine has been given and what to record
- How to put on and take off the personal protective equipment (PPE) required for immunization
- Infection prevention and control measures
- After care for the patient

2) Reconstitution and Aseptic Technique and Patient Overview Video



You will then need to review the videos above. These videos will provide you with an overview of how to reconstitute the vaccine as well provide key insights into aseptic techniques. In addition, you can also view an additional video around an end to end patient journey of a patient receiving the Pfizer BioNTech vaccine.

3) Core Knowledge for COVID-19 Vaccinators – Assessment



You will then need to complete the core knowledge for COVID-19 Vaccinators. You will need to complete this assessment and achieve a pass. You can generate a certificate as required. There are additional sections that can be viewed as part of this programme. These sections will complement the learning obtained in the pre-recorded lectures and videos.

4) Competency Based Assessment



The next step of your learning journey is to complete the Competency Based Assessment. This tool is developed by Public Health England that assesses and ensures anybody administering the vaccine has undertaken the relevant training to undertake this role. Please ensure you complete this.

- The Standard Operating Procedures (SOPs) in your work environment relating to needle stick injury, the importance of cold chain storage, infection prevention measures including the PPE required to deliver the service and undertaking COVID-19 test requirements as directed by your employer.
